Independence Day is a federal holiday in the United States commemorating the Declaration of Independence of the United States, which was ratified by the Second Continental Congress on July 4, 1776.


A Day in the Life of a Village Senior...

This Volunteer experience may have saved a life

I volunteered to deliver a printed copy of the Newsletter to a member who has no internet access.

I knocked on the door Thursday around 11 am. When there was no answer, I went around to the garage door and noticed her newspaper in front. I called and left a message on her home phone. I returned after 4 pm and did the same thing - knocked plus called. Then I asked her neighbor if she was away. Another neighbor was put on alert too. Friday morning (around 8 am) the neighbor informed me a 2nd newspaper had arrived.

CVV keeps Emergency contact information for its members.

I notified the CVV call center. They immediately contacted her daughter who lives in Hayward. She and her husband entered the house and found Mom lying on the floor. They called 911 and Mom was taken to John Muir where she stayed a week in ICU. Mom is now in a rehab facility.

This brings to light the importance of immediate neighbors being aware of any "signs" out of the ordinary, and having each other's phone numbers, and emergency contact information.

Another important thing to consider – who watches the pets and waters the plants while she recovers?

The remarkable neighbors agreed to take on that responsibility.

Otherwise, such services, as well as daily check-in calls, can be requested as part of a CVV membership.


